

Call for papers:
**11th Annual Conference on the
Political Economy of International Organizations**
February 8-10, 2018, University of Wisconsin – Madison, Madison, WI, USA

Submissions are invited for the eleventh annual conference on the Political Economy of International Organizations. As PEIO enters its second decade, the conference will be held at the University of Wisconsin – Madison, Madison, WI, USA, on February 8-10, 2018. The conference brings together economists and political scientists to address political economy issues related to international organizations such as the World Trade Organization, United Nations, International Monetary Fund, World Bank, and the European Union, and also other international organizations that have as yet received less attention in the academic literature.

Submission of Papers

Both empirical and theoretical papers will be considered. Please submit **full papers** via the online submission form at www.peio.me. The deadline for submission is **September 30, 2017**. Decisions will be made by **October 31, 2017**.

Special Issue

After the conference, presenters are encouraged to submit their papers to the *Review of International Organizations* to be considered for a special issue focusing on International Organizations in a New Era of Populist Nationalism, edited by Mark Copelovitch (Wisconsin) and Jon Pevehouse (Wisconsin). Submission to the conference does not require submitting to the special issue.

Conference Format, Attendance, and Registration

The number of participants will be limited to about 80 to allow for in-depth discussion of each paper. Authors of accepted papers are expected to attend the *entire* conference. There is no conference or registration fee. Travel and accommodation are at the expense of participants.

Conference Venue

The conference will be held at the University of Wisconsin – Madison. Direct domestic flights to Madison are available from many major airport hubs, including: New York (La Guardia and Newark), Washington DC (Reagan), Atlanta, Charlotte, Chicago (O'Hare), Dallas, Denver, Detroit, Minneapolis, and Salt Lake City. The easiest international connections to Madison are through Chicago O'Hare (United/Star Alliance, American/OneWorld) or Detroit (Delta/SkyTeam). There is also reliable and frequent bus service (~3 hours) to Madison leaving directly from Terminals 1/2/3 and Terminal 5 (international arrivals) at Chicago O'Hare via Van Galder/Coach USA (<http://www.coachusa.com/vangalder>), should you miss your connection to Madison.
